#### **Collaborative Efforts Feed Students**

The School District packaged ready meals available to families to pick up during what would be regularly scheduled school days. However, this left a gap to fill for Spring Break. Spearheaded by Thunder Island Brewing Company, meals were made for students in Cascade Locks and picked up, free of charge to local families over Spring Break. This effort was sponsored by individual community members, the City of Cascade Locks and the Port of Cascade Locks.

There is a worldwide shortage in personal protective equipment for medical staff due to the coronavirus pandemic. Many businesses and individuals have stepped in the ensure that medical staff are able to perform the duties of their job as well as protect their own health. Cascade Locks business The Renewal Workshop, in collaboration with Immersion Research White Salmon and Sailworks were able to assist Skyline Hospital with clothing their staff head to toe with lifesaving PPE. The Port continues to develop an emergency access road into the Business Park as well. Finally, pFriem building is completed and occupied.
