The Port has finalized a new lease for TIB in its current location in the Marine Park incubator space. The new lease will be for a time period of January 1, 2018 to December 31, 2018 at which time it is hoped TIB will be in its permanent home on WaNaPa Street. The TIB plan documents for the new building have been approved by the Planning Commission. It is anticipated that construction will start in the spring of 2018.

Budget Committee Vacancy

The Port Commission is accepting letters of interest from residents of the port district who are interested in serving their community as a member on the Port's Budget Committee. The Budget Committee of 10 is composed of all five Port Commissioners plus five citizen members. There is currently one open seat; that will fill a 3 year term, ending December of 2020.

Q: What does a Budget Committee Member do?

A: Volunteer budget committee members are expected to attend a preliminary orientation session, plus a series of three to four meetings between April and May of 2018. The committee reviews and revises the draft budget prepared by Port staff in order to support the adopted mission, vision, and priorities of the Port. Previous years' budgets are available for reference. Questions are encouraged. Experience in business and/or budgeting is desirable and helpful.
