# Port Report



#### **About a Port**

Ports are bodies of government tasked with diversifying and improving the economic base of the state. Ports utilize any combination of water, air, and land commerce to achieve this goal. Most Ports are located on a waterway, others are inland. Inland Ports make use of air or land-based transportation networks, industrial properties and other business activities. Although Ports receive a portion of their district's property taxes, the amount is considerably less than what a city or county would receive, therefore requiring Ports to generate their own revenue (similar to private industry) to fund economic projects. For the Port of Cascade Locks, that share amounts to roughly \$4,000/year, leaving the Port to rely on its business activities to general revenues to fulfill its mission. Two of the regional ports, Port of Cascade Locks and Port of Hood River, own toll bridges and industrial properties to generate revenue and support commerce. In recent years, the Port of Cascade Locks made large strides in supporting business development. It developed roads, ran utility lines to lots and built industrial flex buildings. These efforts enabled businesses to start, relocate to, and expand in Cascade Locks. The businesses increased the tax base, adding to the city's revenue and keeping services at lower costs to the residents. Since 2010, the assessed valuation of the City of Cascade Locks grown from \$62 million to \$111 million. Currently, there is at least an additional \$25 million in assessed valuation in development that will hit the tax rolls by January 2022. That growth of property taxes allows the City to maintain a fulltime Fire and EMS Department that protects our citizens. Importantly, these businesses also provide iobs within the community. In the last 10 years, the Port of Cascade Locks has been able to facilitate the starting up or relocating to Cascade Locks of 15 businesses and job providers. This work is ongoing and there is continuous stream of potential businesses interested in being in this community. (Continued on backside)

# **Port Budget Committee Met**

The Budget Committee met again on October 29<sup>th</sup> to approve the 2020-21 Supplemental Budget. The Budget Committee met earlier in 2020 to approve a provisional budget that was implemented on July 1<sup>st</sup>, 2020. This process allowed for the Port to operate conservatively while revenue was down due to the COVID pandemic. Staff was able to reevaluate costs and revenue sources to bring a supplemental budget to the committee for review and adoption for the remainder of the 2020-21 fiscal year.

#### **Marine Park Winterization**

Marine Park has now been winterized for the season. Annually, maintenance staff take steps to protect water pipes and irrigation systems throughout the park. Important points to remember with this process is that restrooms in Center Park are now closed, restrooms and showers in the campground are now closed, water service has been shut off to campground sites 5-12 (1-4 have water year round), water service to the Marina has be shut off, and water service to the cook shacks has been shut off. For the winter season, the only public restroom in Marine Park will be located at the Boat Launch. For Questions, call 541-374-2404.
