# Port Report





## **Over Dimension Permits on the Bridge**

On February 15th, the Port Commission approved a permit process required for over dimension trucks crossing the Bridge. The new policy takes effect on April 1st, and will require over dimension trucks which are over 10 feet in width or over 14 feet in height to apply for a single trip permit through the Port at least 24 hours in advance. With a permit, the Bridge can accommodate up to a 16 foot wide load and up to a maximum of 14 feet 6 inches in height, but nothing exceeding those measurements. The Port, will have the ability to approve the permit or to recommend the Bridge crossing at a different time. Both over height and over width trucks will also still require the presence of a pilot car. Because of the narrow 22 foot Bridge roadway, any over width trucks (over 10 ft.) require a pilot car to stop traffic on the opposite side of the Bridge. This interruption can be very problematic, especially during peak traffic times. A \$10 processing fee will accompany the permit, which will be available at the Toll Booth, Port Office and the Port web page. Over dimension trucks arriving at the Bridge to cross without the approved permit will be assigned a \$25 charge. The Bridge has an 80,000 lb. weight limit, and the Port will not be approving any overweight trucks on the Bridge. This new permit process will improve safety, and help to avoid serious interruptions to traffic flow at the Bridge. Please contact the Port Office at 541-374-2418 for questions.
