The Governor has been very interested in what is going on in Cascade Locks, especially since the fire of last fall. The Governor has committed to giving extra effort to aid in job creation and Cascade Locks.

Marine Park Buildings Assessment

Port staff and tenants have begun the process of assessing the condition of all the Ports buildings in Marine Park. The assessment is being done to develop plans for maintenance, repair and historic preservation for the buildings. The renovation work on the Pony Building was the first project, now the Port will develop a comprehensive list of work to be done to preserve all the structures. The plan is to get the buildings onto a regular schedule for painting, major repair and proper care. In the current budget, the north porch at House 3 will be rebuilt. The two porches at House 2 have been painted utilizing the new color schemes. In addition, House 3 will see about \$10,000 in enhancements designed to increase use and revenue. With the newly adopted Marine Park Master Plan in hand, the Port Commission is very serious about taking excellent care of all the buildings. Because Marine Park was originally deeded over to the Port by the Corps of Engineers and the entire Park is on the National Historic Registry, both agencies are involved in the process.

Roadway Striping

The Port contracted with ODOT to do annual roadway and parking lot striping at Port facilities. This year most of the Ports facilities are in need of better striping so the work will take a little longer. ODOT crews began work on July 17 and completed July 26. The work included replacing the no parking red line, striping parking stalls, queuing up the intersections for better safety and preparing NE Columbia Gorge way for city operations. Most of the work was done in the evening to have minimal impact on Park users and businesses.

The Port wanted to clarify this law after receiving multiple reports of marijuana use on Port property, including Marine Park. Please respect this law and others enjoying Port properties.
